CLEANSSED pulled to the lead entering the first turn, bore out but was restrained under a hard hold, widened the advantage on the second turn despite bearing out further, was kept to task and drew away. SMOKIN STAR settled in hand, moved up four wide to make his bid, but failed to menace the winner and just held the place. PASTOR PUCKETT settled saving ground, angled out leaving the second turn and was along for the show. NACONA contended three wide, but weakened between horses after six furlongs and faded. VITA DESIDERATA pressed the pace two wide to the stretch and tired. FIRE ANGEL settled five wide and was never a factor. WELL WHAT was outrun.
