TIRBRACKEN LILY closest to the pace, challenged three wide on the turn, took over after a half and drew off under steady urging. SONJA'S ANGEL forwardly placed from the outset, challenged between rivals on the turn, could not stay with the winner in the drive but held on for the place. CREDIT CRUNCH outrun early, raced five wide into the turn and lodged a mild late bid. QUITE EXPLOSIVE behind the leaders three wide, faded. BEAUTIFUL TEMPER four wide into the turn, gave way. NEWPORT LULU set the early pace, held on well to the stretch and faded.
