COMPLICITY stalked the pace in hand, ranged up four wide to make her bid, bumped with SILVER TIME entering the stretch, inched away from that one with three-sixteenths to run, drifted in under right handed urging taking the path of MUST BE GOLD forcing that one to steady and alter course to the outside, then was all out to just last. MUST BE GOLD settled saving ground, got through to launch her bid, steadied when COMPLICITY came in inside the furlong marker, altered course to the outside of that rival and was making up ground once clear. NO IMAGE settled in hand, came four wide and loomed a danger entering the stretch but lacked the needed late response. SILVER TIME opened clear to set the pace off of the inside, was collared leaving the second turn, bumped with COMPLICITY entering the stretch and gave way readily thereafter. KENTUCKY PEACHES was allowed to settle and lacked a response when called upon. The Jockey of MUST BE GOLD lodged an objection against COMPLICITY for alleged interference in the drive, but following the review the Stewards made no change to the order of finish.
