BEVIE'S PARTY in tight late on the first turn when within striking distance and between rivals, recovered to race off the inside, came out three wide into the stretch and wore down the leader. DUEL AUTHORITY sprinted clear, set the pace along the inside and just failed to last. MISS BARBARA behind the leaders along the inside, lacked the needed late bid. DANZIG MATILDA unhurried early off the inside, angled out four wide entering the stretch but lodged only a mild bid. AUSTIN RUNNER closest to the early pace three wide, moved in to be off the inside on the second turn and tired in the drive. RIEPE RIDGE outrun early, was fanned six wide late on the second turn and was no threat. AFTER AFTER AFTER steadied along the inside on the first turn, was unhurried, was fanned five wide leaving the second turn and could not menace. A J BEAR outrun early, raced three wide on the second turn and was no factor.
