Footnotes

ETHICAL LAWYER settled saving ground, moved up three wide through the second turn, bullied his way between rivals entering the stretch, angled to the inside and was all out to narrowly prevail. FOLOWTHEMONEYTRAIL attended the pace in hand off of the inside, swung five wide to make a bold bid, opened clear a furlong out, fought on well but wasn't quite good enough. BIG PICTURE GUY set the pressured pace three deep between rivals, weakened entering the stretch but had enough left to earn the show. TIGER STRIKE contended along the inside, got through entering the stretch, was put in tight inside the three-sixteenths pole and flattened in the drive. CHAMPION ECLIPSE was unhurried into stride, closed the gap four wide, angled out further entering the stretch but failed to sustain the effort. MOUNT DOLLBERG was close up four wide to the stretch and faded. LYDDON pressed the pace between horses, was bumped and steadied inside the three-sixteenths pole and showed little thereafter. SUN VALLEY AL was outrun. OLD HARLEY broke in the air, was away well behind his field and never recovered. Following a Stewards inquiry into the stretch run, ETHICAL LAWYER was disqualified from first and placed seventh for bearing in and taking the path of LYDDON inside the three-sixteenths pole.
