**Footnotes**

EVIL TRICKS behind the leaders along the inside, angled out on the second turn, challenged four wide with a quarter mile to go and drew clear late under steady urging. DIXIE NIMBLE vied for the lead off the inside and held on gamely in the drive. RED DELICIOUS close up three wide, challenged on the second turn but weakened in the final furlong. SYRIAN MAIL outrun early, raced in the four path on the backstretch and second turn and lacked a solid late bid. CHANNEL VISION reserved early, made a mild gain three wide on the second turn but had little left in the drive. ASCENDING LIGHT alternated for the lead along the inside and gave way the final furlong. KISSEMPPLAIN was outrun.
