AZTEC KING set the pressured pace between horses, drifted out leaving the turn, but kept on willingly and was fully extended to lead throughout. CHESS MASTER veered out at the start and was away slowly, ranged into striking distance four wide, was carried out further leaving the turn but was getting to the winner steadily. ARCHIE TRUCKER disputed the pace along the inside, weakened slightly following a prolonged drive and grudgingly gave way. CACTUS FEVER tracked the pace off of the inside, came three wide and got through entering the lane, but lacked the needed late response. RESTLESS CITY failed to respond. MR. ALDO broke in the air to get away behind his field and was never a factor.
