LUCKY CHUCK pressed the pace four wide, took over on the backstretch, increased his lead on the second turn and lasted late. EYE FOR AN EYE vied for the lead off the inside, drifted out in midstretch then was gaining late. SHAKEYOGROOVETHING within striking distance in the four path, moved out to be five wide on the second turn, was carried out by the runner up in midstretch then finished willingly late. HARBORPLACE prompted the pace three wide, was carried out in midstretch then squeezed back near the sixteenth marker then lodged a mild bid. BORDEN BRAVE was outrun. Following a foul claim by the rider of HARBORPLACE, EYE FOR AN EYE was disqualified and placed fourth for interference in the stretch.
