DEPUTY DARLING reserved for a half, advanced three wide on the second turn, challenged approaching the stretch and drew off under steady handling. ELLIDAY set the early pace, dropped back in the run down the backstretch, came out four wide entering the stretch and came again for the place. KENTUCKY PEACHES forwardly placed from the start, held on well to the stretch and tired. NO IMAGE close up early, dropped back after a half, steadied in midstretch, angled out soon after but was no late threat. ROSE OF KILLARNEY unhurried early, made a good middle move to challenge between rivals late on the second turn but tired in the drive. EMPIRE MOON within striking distance along the inside, faded.
