TIBAN set the pace early, angled off the rail into the turn then drew off in the stretch under a steady drive. BARON SLEW chased the pace early, angled into the four path in the turn and weakened late in the drive. CHAPTER TWELVE tracked the pace early, angled into the three path in the turn and faded late in the stretch. STEVE'S BIG MOE was unhurried early, angled off the rail into the turn and moved up in the stretch run. TOUCH ME QUICK angled into the five path in the turn and improved position. VARVATOS was done early. TASTEFORCHAMPAGNE showed little. TIGER WOZ was through after a half. POWER PARTS was never involved. HOMER T trailed the field throughout.
