HAWAIIAN SKY ducked out at the start soundly bumping COMMADORE KATE, raced behind the leaders four wide, moved boldly to the lead in that path on the second turn, quickly drew off and was not menaced while doing her best. ECHOES RESOUNDING within striking distance five wide, moved in a path on the second turn and lodged a mild bid for the place while no threat to the winner. DEVIL'S LIL BIT vied for the lead along the inside and tired. COMMADORE KATE bumped at the start, was reserved for a half, angled five wide leaving the second turn and could not menace. THIMBLEBERRY bumped at the start, raced five wide on the second turn and never threatened. HILLY M broke in air, forced the pace three wide and faded. SNICKLEBRITCHES prompted the pace off the inside and gave way.
