BRIDANTY close up, saved ground on the turn, waited behind the leaders midway through the turn, angled out and rallied willingly to be up in time. SOCIAL APPROVAL alternated for the lead along the inside and held on gamely while drifting out late. TOMISUE'S WAY close up three wide, challenged late on the turn, gained a short lead and also held on gamely while being carried out late. BLAZING BLISS within striking distance, raced four wide on the turn and lacked the needed closing bid. HONEYMOON BABY outrun for a half, rallied belatedly. BRAVE LADY within striking distance along the inside, tired. ROCKETS GLAR vied for the lead off the inside and gave way. MOTEL CHLOE was outrun. Following a stewards inquiry, SOCIAL APPROVAL was disqualified and placed third for interference in the stretch.
