FOR FILLIES AND MARES, FOUR-YEARS-OLD AND UPWARD. No nomination fee. \$250 to enter and \$250 additional to start. Supplementary nominations may be made at the time of entry Wednesday, March 26, 2008 by payment of \$2,500 each (includes all fees). \$50,000 Guaranteed. After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 121 lbs. Non-winners of a Sweepstakes at a mile or over since December 1, allowed 2 lbs.; \$25,000 twice at a mile or over since September 5, 4 lbs.; \$21,000 at a mile or over in 2008, 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters. Preference to start will be given in the following order: Graded/ Group stakes winners (in order I-II-III). Stakes winners, then highest total earnings in 2007-2008. In addition no same owner entry may start to the exclusion of a single entry. Failure to draw into the race cancels all fees. Closed Wednesday, March 19, 2008 with 35 Nominations.

PRINCESS COMPOSER vied for the early led four wide, moved in a bit while battling then edged clear late under steady urging. DELICATE DYNAMITE forwardly placed three wide, challenged after a half, pressed the winner thereafter and held on gamely while not quite good enough. TRY TO REMEMBER vied for the lead off the inside and weakened late. PROMISE ME A PRIZE reserved in the two path, lacked the needed closing bid. FUN LOGIC within striking distance four wide, had little left late. SWEETDOWNTHELANE close up while off the rail, weakened. DEMISEMIQUAVER (GB) within striking distance in the five path, challenged four wide on the second turn, held on well to the stretch and tired. LA PEROUSE four wide early when outsprinted, raced in the five path on the second turn and could not menace. TRANQUILITY lost her footing a bit at the start, recovered to be close up near the rail but gave way.
