### Footnotes

NOLA STAR was away alertly to set a clear pace, dug in gamely to meet the challenge of HILLY M leaving the second turn, drifted out under left handed urging and bumped that one nearing the furlong marker, came out again taking the path of HILLY M and bumping NO IMAGE inside the eighth pole, was straightened away and was all out to narrowly prevail. NO IMAGE was allowed to settle into stride, launched a bold bid five wide, was bumped during the drive when NOLA STAR came out and was unable to reach the winner. LEGAL MOTION was unhurried into stride, made a late rally circling six wide and was up in time to earn the show. HILLY M settled in hand, ranged up four wide to engage the leader, was bumped nearing the furlong marker when NOLA STAR came out, steadied when that one came out again taking her path inside the eighth pole, altered course to the inside and came again once clear. REVIEW MY ACCOUNT contended between horses to the stretch and faded. BURKE'S SISTER was forwardly placed along the inside for six furlongs and tired. STEELA chased the pace four wide for a half and retreated. CRASHING SANDSTORM was rank to place, settled along the inside but showed little thereafter. The Trainer of HILLY M lodged an objection against NOLA STAR for alleged interference in the drive, but following the Stewards review there was no change to the order of finish.
