ROSE'S CAT sped clear to set the pace and gamely led throughout. U. S. BONDS stalked the pace three wide, launched her bid entering the stretch, finished willingly was getting to the winner late. WICKED PRINCESS was hustled along removed from the rail to attend the pace, lacked a response when called upon and was all out to hold the show. FOXTAIL JILL was allowed to settle into stride, advanced from between horses through the turn, angled out to find room entering the stretch but lacked the needed late response. BRIDLED STAR was unhurried early, came four wide to make a mild gain, but was carried out further entering the stretch when FOXTAIL JILL came out and weakened. AQUA JEAN angled out five wide to be clear entering the turn, was forced out deeper entering the stretch and failed to respond. STAKE YOUR CLAIM made a middle move four wide to offer a mild bid, but failed to sustain the drive and dropped out. QUITE A FLIGHT was through before going a half.
