TIMBUCTO sped clear to dictate terms and remained unchallenged. GHOSTWALKING was allowed to settle, circled four wide to make his bid, was unable to reach the winner but kept on well to clearly prove second best. DONT POKE THE BEAR was unhurried into stride, swung six wide to make a late rally and was along for the show. MUTINY contended between horses to the stretch and faded. MOMILLIONS settled saving ground, made a middle move to close the gap, offered a mild bid but failed to sustain the drive. SEVEN IN HEAVEN was close up three wide to the stretch and retreated. DR. DUNKENSTEIN was unhurried into stride, made a mild rally four wide through the second turn, but came up empty entering the lane and dropped out.
