Footnotes

HAUTAIN reserved early, advanced five wide on the second turn, challenged once in the stretch and edged off late. CHEROKEE NATION four wide on the first turn when forwardly placed, moved in a path for the 2nd turn, challenged in midstretch and held on gamely. SACRED BATTLE fractious in the gate, broke slowly, was outrun early, made a bold six wide run on the second turn, reached a forward position with a furlong to go but hung. BEHRENS DESIGN set the pace off the inside and weakened late. ROYAL HONOR reserved for a half, made a three wide middle move but had no late bid. H D'S AFFAIR far back early, rallied belatedly. IMAGINARY HERO six wide on the first turn when within striking distance, stayed in that path on the second turn and tired. GENERAL TALK forced the pace along the inside and tired. TENDENCY close up early, raced along the inside on the second turn and faded. SULTRY PLEASURE five wide on the first turn when forwardly placed, held on well for five furlongs and faded. HOLLYWOOD VIC was outrun. DEVON SANDS was no factor.
