GENERAL PURPOSE forwardly placed, advanced four wide late on the turn, challenged soon after and drew clear under steady urging. SUMMER MAN vied for the lead in the four path, was no match for the winner but held on for the place. SKIPTOTHEGOODPART outsprinted early, made a run six wide on the turn, challenged in midstretch but tired late. EECCHHOO within striking distance in the five path, lacked a closing bid. LAZ HAS RISEN never far back, moved to the inside approaching the stretch but had nothing left late. SLEWBISCUIT forced the pace three wide while between rivals and tired. CONJURER contested the pace off the inside and faded. JUMONVILLE vied for the lead, saved ground on the turn and gave way. PUNCH was outrun. HANK'S RIB outrun, was eased in upper stretch and vanned off.
