PORTMAN outrun early seven wide, angled in a bit, made a run five wide on the second turn and closed well to be up in time. C FOR CHANT reserved along the inside, angled out for the drive and finished willingly late. TITANIUM TUFF reserved five wide, angled in a bit, moved up three wide on the second turn, caught the leaders with a furlong to go and held on gamely. PICKEMUPTRUCK set the pace off the inside, stayed out in the three path on the second turn, held on well to inside the final furlong and tired. POTENTIAL PLUS forwardly placed four wide, stayed on well to the stretch and tired. ARJUNA within striking distance three wide, gave way. PARK AND FLY seven wide early, failed to menace. TANGO KING six wide early, was no factor. LIGHT OF THE STORM was through after a half. JUDGE GRAY closest to the pace inside, stopped. BESTUS steadied in traffic into the first turn, stayed on for a half and stopped. SHAH EN SHAH was outrun.
