RUNNINFORROB came in a bit entering the first turn placing RIDGE CITY in tight, set the pace inside and stayed clear under steady urging. SHADES OF HOPE pressed the pace outside the winner, could not run with that one but held on to be second best. RIDGE CITY in tight entering the first turn, recovered to be forwardly placed but tired in the final quarter. RED BAYOU within striking distance to the stretch, gave way. HERZSCHMERZ was outrun. A FOUL CLAIM BY THE TRAINER OF RIDGE CITY AGAINST THE RIDER OF THE WINNER FOR INTERFERENCE ON THE FIRST TURN WAS NOT ALLOWED.
