PART GIRLIE GIRL stalked the pace, dueled around the final turn, rallied to edge clear in the final furlong. INSIGHTFULLY never far back, rallied four wide past the quarter pole while only second best. CHAMP LAILA reserved early on, raced off rail into the stretch with a mild late gain in the drive. DEANNA'S DREAM rated off slow pace inside, came up empty in the drive. THIMBLEBERRY lunged at the start, lagged back to the stretch and only passed one late. WAHL OF FAME set a pressured but slow pace and gave way after a half. BARBATINA always trailed.
