STRATEGIC DECISION opened clear to dictate terms, was well rated and gamely led throughout. ADARO tracked the pace three deep, was unable to match strides with the winner but kept on well to prove the best of the rest. OUR KING was forwardly placed along the inside to the stretch, weakened but had enough left to hold the show. GERI'S KID was unhurried into stride, angled out entering the stretch and finished with a belated gain. SAVIANO contended between horses but lacked a response when called upon. MR. WATT was between horses early, shifted out four wide but came up empty after six furlongs and retreated. WICKLOW COUNTY settled saving ground, checked hard midway through the first turn, altered course to the outside, made a middle move five wide but faltered entering the stretch and dropped out.
