SPEND AND SPREE stalked the three wide, came four wide to make a bold bid, forged command with a furlong to run and held the fast closing MAMA DECIDES at bay. MAMA DECIDES settled saving ground, swung wide entering the stretch, finished well but was unable to bridge the gap. HONEYMOON HOTEL set the pressured pace along the inside, weakened during the drive but had enough left to hold the show. HOPEFUL SWEEPER vied for the lead three wide, but faltered between horses entering the stretch and faded. RUPERTACTOFDUTY was allowed to settle, finished with a belated gain and improved position. TRUST N YOU contended off of the inside, but lacked a response when called upon. YALLAH LEAH failed to respond. PUZZLING MOVE broke slow and passed only the tiring ones. BOOGIE WOOGIE was hustled along between horses, but came up empty leaving the turn and retreated. LIBEL AND SLANDER showed little. RUNNINGONAPRAYER prompted the pace between horses, but stopped before going a half.
