Footnotes

CANELA close up four wide, responded in the stretch and drew off late. CODE BLUE forced the pace from the four path, took over on the second turn but was no match for the winner late. SHOT GUN CLIFF reserved five wide, made a solid five wide middle move, dropped back a bit into the stretch then made a late gain. CHOSON outrun early three wide, moved out a path on the second turn and was no real threat. MAGICAL COURT reared at the start, was outrun five wide, made a six wide run on the second turn but could not sustain the bid. NOROAMIN four wide on the first turn, was no threat. SHENG was no factor. WORKINONTRAILROAD alternated for the lead off the inside and faded. NAFASS within striking distance early, faded. SATYRS never menaced while three wide. SIDEWINDER vied for the lead off the inside and stopped. LAST DEMAND had speed for a half.
