Footnotes

CANFIELD stalked the pace along the inside, got through entering the stretch, forged command a furlong out and edged clear. EAST COAST TRAIL stalked the pace in hand, came four wide, quickened late between horses and was up for the place. REPENTANT SPIRIT was unhurried into stride, circled six wide and was along for the show. TWO STEP HERO disputed the pace off of the inside, fought on through a prolonged drive but grudgingly gave in late. RULE MY HEART was allowed to settle, angled in to save ground, got through and finished with a mild rally. ALIGNED was close up four wide to the stretch and faded. RIDGE CITY failed to respond. MELVIN HILL was allowed to settle, moved up between horses on the second turn but came up empty entering the stretch. DONTLOOKMEOVER broke slow, was hung wide throughout and was never a factor. CONTENDER vied for the lead four wide for six furlongs and dropped out. MEMPHIS DISTRICT was through after a half.
