Footnotes

IMA GIVEN pressed the pace early then took over the lead, angled off the rail in the turn and drew clear late in the stretch under a steady drive. BLUE SILK tracked the pace early from the outside, angled into the three path in the turn with no gain on the winner in the stretch. DYE AND DENY was unhurried early, angled into the four path in the turn with some gain in the stretch drive. TRIPLE STRAND was back early, swung widest into the lane with a belated gain in the stretch run. LETHERDOHERTHING was well placed early, fanned into the eight path in the turn and moved up in the stretch. IN CASE OF SNOW led the field early, angled into the five path in the turn and gave way late. PARTNERS R DUE was through after a half. SHINY PEMMY was never a threat. BETTY STIRLING was never involved. TWOSOCKSSEVEN was done early. GO BABY GOLD stalked the pace early then soon retreated. A. P.'S SPICE broke down.
