FINEST VISION settled in hand, responded when put to pressure nearing the three-eighths pole, ranged up swiftly five wide, drew even entering the stretch, bumped with MONA ZONE near the three-sixteenths pole, shook off that one and quickly drew clear. MONA ZONE vied for the lead four wide, edged clear on the second turn, was collared entering the stretch, drifted out and bumped with the winner in upper stretch, was unable to match strides with that one but stayed on willingly to hold the place. CRIMSON FIRE was caught in tight and steadied entering the first turn, settled off of the pace three wide, loomed a danger entering the stretch but lacked the needed late response. CART'S CRUSIN settled saving ground, angled out on the second turn, came four wide and improved position. FULL OF FLASH attended the pace off of the inside, moved up between rivals to make a mild bid with a quarter to run but failed to sustain the drive. MI VIERA was unhurried into stride, finished with a belated gain but failed to threaten. TIA RUFINA was unhurried, made a mild late gain between horses but was never a factor. REINA SOFIA was hustled along four wide for five furlongs and retreated. RIVIERA CAFE settled in the second flight and failed to respond. BECAUSESHECAN pressed the pace between horses for six furlongs and dropped out. HAMMERED IN HEELS vied for the lead along the inside for a half and stopped.
