SALE NOTES broke awkwardly, was unhurried into stride, wheeled out six wide entering the stretch, finished with a surge and was up in the final jump. GOING GAGA attended the pace three wide, angled in leaving the turn, got through and forged a late lead, kept on well but was denied in the last jump. JUSTICE JUDY was allowed to settle, came five wide and was making up ground. LITURGY dueled off of the inside, opened clear entering the stretch, but faltered during the drive and gave way. PUCKER UP PHYLLIS was allowed to settle, finished with a belated gain but failed to threaten. FIRST SQUAD saved ground to no avail. MARY MAGDALENE dueled for the lead three wide, but stopped leaving the turn.
