FOR FILLIES AND MARES THREE-YEARS-OLD AND UPWARD. No nomination fee. \$250 to enter and \$250 additional to start. Supplementary nominations may be made at the time of entry Wednesday, December 5, 2007 by payment of \$2,500 each (includes all fees). \$50,000 Guaranteed. After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three-Year-Olds; 123 lbs.; Older; 124 lbs. Non-winners of a Sweepstakes at a mile or over in 2007, allowed 2 lbs.; \$25,000 twice at a mile or over in 2007, 4 lbs.; \$21,000 at a mile or over since October 4, 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters. Preference to start will be given in the following order: Graded/Group Stakes Winners (in order I-II-III). Stakes winners, then highest total earnings in 2007. In addition no same owner entry may start to the exclusion of a single entry. Failure to draw into the race cancels all fees. Closed Wednesday, November 28, 2007 with 55 Nominations.

Footnotes

HALF HEAVEN secured good position to the final turn, ranged up three wide entering the stretch and edged clear under careful handling and held sway. MARQUEE DELIVERY reluctant to load then never far back, went four wide around the turn and was gaining at the end. APRIL FROST unhurried early, moved through traffic around the final turn, attempted to split horses twice through the final furlong and altered course both times then made up ground when finally clear in the late stages. WATER GAP up close with the leaders, stayed well to the stretch but had no late bid. PUT AWAY THE HALO showed good speed from the outset, sprinted clear down the backstretch but weakened from the rail late. GENEROSITY stalked the lead for a half but could not go on and weakened after three quarters. DASHES N DOTS stayed within striking distance for a half but gave way. NOW MORE THAN EVER was never a menace. LE CHATEAU showed no speed, made a middle move while wide but dropped back. GIRLS PEARLS had a steady fade.
