WIN TUCKER broke awkwardly from the gate and was bounced around early, angled into the five path in the turn then rallied in the stretch and was up late in the final strides. RECKLESS CAPOTE was unhurried early, angled into the four path in the turn then made a bid in the stretch and led late but was caught in the final stages. FRENCHMAN'S COVE set the pace early, angled off the rail into the turn remained with a short lead in the stretch but was overtaken late. PRAYER ANSWERED was well placed early, angled into the four path in the turn, made a bid in the stretch but weakened late. CAPTAIN CANAVERAL stalked the pace early, angled off the rail into the turn with no late bid in the stretch run. SILVER BAYER was back early, angled off the rail into the turn with a mild gain in the stretch. ON TOUR broke awkwardly from the gate then chased the pace early, angled into the three path in the turn and was empty in the stretch drive. WAIT ON TATE raced up close early from the inside, stayed on the rail into the turn and faded late. BILL HARV RIB was

never a threat. U D GHETTO had brief speed then retreated. TENCATI was done early. SADLER'S CAT was unprepared at the start and outrun.
