DABA DABA rushed to the lead along the inside, opened clear on the turn, widened into the stretch and held safely. ZAK BENATE prompted the pace two wide, came three wide and kept on well to earn the place. DIEU ET LES DAMES attended the pace in hand, got through entering the stretch to make his bid but lacked the needed late response. WOOD QUAY was close up four wide, came five wide but came up empty in the drive. WILDCAT HUMOR was allowed to settle five wide and failed to respond. DR. CALAHAN saved ground to no avail. DANCE TO THE WIRE was away alertly to set the pressured pace, but faltered entering the stretch and faded. HARLEY'S CAT showed little. TWINKLE STAR was outrun. PER STEWARDS RULING NUMBER 12-0031 DABA DABA WAS DISQUALIFIED FROM FIRST AND PLACED LAST.
