Footnotes

NINA NINA was well placed early, angled into the five path in the turn then rallied in the stretch and drove past the leader late under a steady drive. DAILY GRACE stalked the dueling leaders early, angled into the three path in the turn then took over the lead in the stretch but was caught in the final stages. CHARLOTTE STORMCAT dueled early, angled off the rail in the turn then faltered late in the stretch drive. ELUSIVE RESPONSE was unhurried early, angled into the five path in the turn then moved up in the stretch. COURT SKIMMING was settled off the pace early, angled off the rail in the turn but lacked a late bid in the stretch run. TWO FIFTY SEVEN was back early, swung into the six path in the turn and improved position late. YANKEE SILVER tracked the pace early, angled into the four path in the turn and faded late. CHOCOLATE STEEL was never a factor. HONOR LOIS dueled early from the inside, stayed on the rail in the turn and gave way in the stretch. GENTLE STORM broke awkward from the gate while no threat. DEE DEE TEE was done early. EXINE broke awkward from the gate and was outrun.
