**Footnotes**

LADY ON FIRE broke out and bumped rivals leaving the gate then veered in while entering the first turn, continued to set the early pace, angled into the four path in the far turn and remained clear in the stretch, held sway in the final stages. TAWDRY steadied early entering the first turn and settled in the back of the field, angled into the four path in the far turn with a late gain in the stretch run. TELLALITTLESECRET was bumped hard at the start and trailed the field early, angled into the three path in the far turn with a late gain in the stretch drive. TOP SMOOCHER was bumped at the start, angled into the five path in the far turn then made a bid in the stretch but flattened out late in the drive. LIL AMERICAN stalked the pace early, while on the inside into the far turn and weakened late in the stretch. MINNIE SUNSHINE swung into the six path in the far turn and improved position. SEPTEMBER CEREMONY tracked the pace early from the inside, angled into the three path in the far turn and was empty in the stretch. ANGELS CAN BE WILD was through after a half. IN THE FRAME had early speed then folded up. THE RIDER OF TAWDRY CLAIMED AN OBJECTION AGAINST THE RIDER OF LADY ON FIRE FOR INTERFERENCE ENTERING THE FIRST TURN BUT IT WAS DISALLOWED.
