**Footnotes**

MISSISSIPPI HIPPIE set the pressured pace three wide, opened clear midway through the turn, fought on and maintained a diminishing advantage. LAWYER DAGGETT settled in hand, advanced between horses through the turn, got through entering the stretch and was making up ground. O'RIAIN was allowed to settle, circled six wide and was along for the show. PAINTED FOREST chased four wide, drifted out entering the stretch and weakened during the drive. OUR TWO prompted the pace between horses, was unable to match strides with the winner leaving the turn, faltered further in the final furlong and faded. BURN ONE TURN ONE was slow into stride, finished with a belated gain but was never a factor. RESTLESS CITY failed to respond. THUNDER HIGHWAY was hustled along between horses, came six wide but went evenly. GO R V GO broke awkwardly and showed little thereafter. BILL HARV RIB was forwardly placed along the inside but was through before going a half.
