Footnotes

COALINGA tracked the pace early, angled off the rail into the turn then took over command in the stretch and drew clear late under a steady drive. LEISURELY WALK was unhurried early, angled off the rail into the turn with a late gain in the stretch run. CHECKITOFF was well placed early, angled into the five path in the turn with a mild gain in the stretch drive. MADALIN NICOLE was far back early, angled into the three path in the turn with a belated gain in the stretch. CAMPEONA ALI set the pace early, while on the inside into the turn and faltered late in the stretch. FORBID THE QUEEN chased the pace early, angled into the three path in the turn and weakened late. POSEN GAL was never a threat. MISS DEWEESE INLET was never a factor. BOOGIE RED was done early. FIT TO BE TIED steadied in the backstretch. LEGS GALORE had brief speed then folded up.
