MISS AMPLIFIED pressed the pace along the inside, poked her head in front after a half, drifted out through the drive bumping MISS DEWEESE INLET repeatedly and was fully extended to prevail. MISS DEWEESE INLET disputed the pace two wide, was bumped and carried out through the drive and grudgingly gave way following a prolonged drive. KNOCKSMEOFFMYFEET attended the pace along the inside, got through entering the stretch and was all out to earn the show. EVER ENDEAVOR stalked the pace four wide, offered a mild bid entering the stretch but flattened out during the drive. BRIGHT REPLY was unhurried into stride along the inside, got through and improved her position through the stretch. GGLAD was unhurried into stride, made a late rally six wide but failed to seriously threaten. MADALIN NICOLE made a middle move five wide to close the gap but failed to sustain the drive. STING IN THE TAIL hopped at the start to get away slowly, was hung eight wide through the turn and never a factor. LUCYS SULTRY MOVES failed to respond. JACKIE'S WEDDING prompted the pace three wide for a half and dropped out. NASHVILLES BEAUTY was through early. Following a Stewards inquiry MISS AMPLIFIED was disqualified from first and placed second for drifting out under left handed urging and bumping MISS DEWEESE INLET repeatedly

and carrying that one out through the stretch.
