SARAH DOUGLAS tracked the pace four wide, assumed command after the opening quarter, shook clear entering the stretch and widened through the drive. EAST END HOUSEWIFE was allowed to settle, angled out leaving the turn, split rivals entering the stretch and finished well to earn the place. QUEEN OF SCIOTO disputed the pace along the inside, was unable to match strides with the winner, proved unable to resist the runner up for the second spot and settled for the show. LA JEZEBELLA was unhurried into stride, came seven wide but found her best stride too late. GOSSIPER vied for the lead between horses, but weakened leaving the turn and gave way. CASTLE DREAMER settled saving ground, got through to make a mild gain but failed to threaten. SLEW WATER SLEW contended between horses to the stretch and tired. DEAN AVENUE was hustled along four wide, drifted out seven wide leaving the turn and came up empty after a half. HAPPY KARMA was forwardly placed off of the inside to the stretch and retreated. MISTY'S ARROW broke slowly and was never a factor. HOLD THAT PLACE was through early. TIGER'S VICTORY was outrun.
