**Footnotes**

DOUBLEFOUR was far back early, fanned into the seven path in the far turn then rallied in the stretch and drove clear late under a steady drive. WHEREAS DENTON was unhurried early, angled into the four path in the far turn then made a bid in the stretch but yielded late in the drive. COLD FEET tracked the pace early, angled into the three path in the far turn, made a bid in the stretch but weakened late. DANCING DON steadied into the first turn and was back early, fanned into the seven path in the far turn and moved up in the stretch run. SARKOZY angled into the three path in the far turn and improved position. P. R. VICTORY was well placed early, angled into the three path in the far turn and faded late. AUGMENT swung into the six path in the far turn while no threat. CECILSLUCKYMISTAKE dueled early, angled off the rail into the far turn and was empty in the stretch. FOR MEN ONLY was through after a half. NOLA STAR was through after three quarters.
