SWEETNESSNGOODNESS pressed the pace early, angled off the rail into the turn then took over command and drew clear in the stretch and held sway in the final stages. RUSTICANA tracked the pace early, angled into the three path in the turn then made a bid in the stretch but flattened out late in the drive. BLUSHING MARTHA chased the pace early, angled into the five path in the turn and weakened late in the stretch run. FOREST ANGEL set the pace early, while on the inside into the turn and gave way in the stretch. WORSHIPPER was never a threat. VICTORIAN DIVA was done early.
