COURT'S JOURNEY close up four wide, challenged on the turn, battled the runner up through the stretch and proved narrowly best while brushing with one late. SAVETHETANGOFORME close up while off the inside, challenged on the turn and held on gamely but was outfinished while brushing with the winner late. SMOKINEXPECTATIONS forwardly placed along the inside, maintained good position to the stretch and tired. DREAM OF PERTH within striking distance in the three path, gave way after a half. HE CAN HE WILL outrun inside, was no threat. BROKEN TANGO outrun off the inside, was no factor. DANDY SANDY within reach of the lead five wide, faded in the final quarter. SCORCERER set the pace in the three path, held on well to the stretch and gave way. ROCKY BEAR unhurried in the three path, came five wide out of the turn and stopped and bled. A FOUL CLAIM BY THE RIDER OF SAVETHETANGOFORME AGAINST THE RIDER OF THE WINNER FOR INTERFERENCE IN THE STRETCH WAS NOT ALLOWED.
