TIZ IN COURT sprinted clear to set the pace and held safely under mild urging. DECARCHY FEVER chased the pace, couldn't gain ground and was no match for the winner. LOUIE TRE lagged early, bid six wide and got up for show while no threat to the top two. DINNER WITH DAN raced in the middle of the pace, bid, hung and dropped back. NOT OPPOSED failed to menace in an even effort. STORMY AMBITION stumbled at the start, saved ground while racing within striking distance, bid along the rail on the turn and came up empty. WHAT A LASER was steadied at the start and failed to contend in a wide trip.
