NICCOLO'S DANCER never far back and outside, raced in the five path into the stretch and lacked the needed response. WINTER CANYON raced off the inside on the turn and lacked a rally. RIO DIABLO lacked a rally. HAMMETTS WISEMAN chased inside and tired in the drive. DA MICK lacked a rally. SPECTACULAR PULPIT chased early and weakened on the turn.
