SHINY SKY tracked early, chased the top one through the lane and was second best. MISS LAKE broke alertly then up close inside, chased through the lane and lacked the needed late response. YEA IM A REDHEAD hesitated just slightly at the start, saved ground and gained some late. GLORIOSO raced just off the inside and lacked the needed rally. MALIBU BULLET up close early, chased three wide on the final turn and weakened in the drive. RUBYLONGSTOCKINGS saved ground and lacked a rally. JUAN'S BABI lacked a bid. The stewards posted the inquiry sign concerning the winner during the stretch run prior to declaring the original order of finish official. CLASSIC JOURNEY WAS DISQUALIFIED FROM FIRST TO UNPLACED FOR A MEDICATION VIOLATION.
