ONE CALL always a factor and three wide turning for home, finished gamely and prevailed at the wire. MANSIONES saved ground while close up, reached the front along the rail in the stretch then just missed. FUSAICHI SAINT raced four wide into the lane while looming a threat then weakened in the drive. RIO TORRE set the pace, raced in the two path into the stretch and weakened in the drive. WESTERN STRIDER lacked a rally. ABSOLUTE TRUTH raced outside into the far turn and lacked a bid then tired through the lane.
