TOMMY AND BUSTER broke in some, advanced outside on the turn, came in bumping a rival a sixteenth out and edged clear at the wire. CAUSE I'M A BLURR broke out slightly, moved up inside early and quickly drew clear entering the main track, saved ground and was bumped a sixteenth out then could not match strides with the top one nearing the wire. RATON PASS bumped lightly at the start, moved out in upper stretch and earned the show. HOLY BUCKETS chased just off the inside and weakened in the drive. DEANS DANCER raced near the rail and lacked a rally. SIDEWALK SINGER bobbled some at the start, chased and weakened through the lane. BULLITTONE saved ground and lacked a rally. TANKER YANKER raced outside into the turn and lacked a response. Following a stewards inquiry and a claim of foul by the rider of CAUSE I'M A BLURR against TOMMY AND BUSTER for stretch interference, the latter was disqualified from first and placed second.
