### Footnotes

PICO PETE up close early and between rivals entering the turn, raced four wide into the lane and finished well to prevail. WANTED POSTER lodged a four wide bid on the turn and reached the front turning for home, raced in the five path entering the lane and held on gamely while unable to match the top one late. SKID saved ground to the lane, raced between foes late and finished willingly inside. IRONSIDES saved ground and vied for the lead then weakened late. WORLD OF COLOR five wide on the turn, raced six wide into the stretch and lacked a rally. I'M THE GOLD raced off the inside on the turn and lacked a rally. HILLBILLYHARLAN prompted the early issue three deep, vied for command on the turn then tired in the drive. DIVORCE ATTORNEY bumped at the start, vied for the lead between foes and weakened through the lane.
