QUEEN SENSATION lunged some at the start then up close three wide and between rivals into the turn, took over passing the eighth pole then drew off under hand urging. BEAR FACTS raced in the three path into the stretch and closed well while clear for the place. HAVEUSEENMYDADDY set the pace inside and weakened in the drive. REASONABLE EFFECTS lunged out at the start, raced just off the inside turning for home and lacked the needed stretch response. ONE FINE LADY pressed the issue and tired through the lane. EQUIP came in at the start and rank early, was in the six path entering the stretch and lacked the needed response. TOYON BAY broke a bit slow and bumped leaving the gate, saved ground and had no bid. CHELOKETTE four deep into the turn, chased and weakened through the stretch.
