Footnotes

BAILEY ROAD moved to the rail approaching the backstretch then vied for the lead to the stretch, widened the advantage at mid-stretch then responded to left-handed urging to hold safe a late challenge. LITTLE RED EAGLE vied for the lead while slightly removed from the rail, dropped back some in upper stretch then was gaining again on the winner in the late stages. COUNTY TUNE was between foes into the far turn, came four wide for the drive and lacked a bid. KICKAPOLE dropped over to the rail shortly after the start into the first turn, moved off the rail and was four wide on the far turn then altered course again to the inside in upper stretch and lacked a bid. CELEBRATE FREEDOM was just off the early leaders, moved up into the far turn then lacked a further response. SHARP SOUNDS tried to rate off the leaders into the backstretch, saved ground around the far turn and tired. CLAIM THE THRONE tried to lug out into the first turn then rushed up to the leaders into the backstretch, was four deep down the backstretch but was through into the far turn. DOC MARATHON was never in contention, took the three path on the far turn and stopped in the stretch.
