I'M THE GOLD bumped entering the first turn, raced mid pack, rallied into the second turn, went four wide entering the stretch and got place while no match for the winner. LUCAVA raced in the second flight, offered a mild bid inside and was along for show. SKY TERRY vied two across to the second turn, tired and gave way. EY SEE DEE SEE raced in the second flight inside, lacked a bid and was outrun. HUMBOLDT NATIVE failed to contend and was not urged in the stretch. ROYAL CREEK CAT broke awkwardly and bumped at the start, bumped entering the first turn and was never a factor. SMOKIN MOJO broke awkwardly and bumped at the start, fought rating and was restrained to the backstretch, fell far back and failed to contend.
