VONN NEZ set a pressured pace to the second turn, drew clear, was under pressure late but held on gamely. CLASSIC JOURNEY pressed the pace two across, fell back on the turn, continued willingly to the wire and was outfinished in a good effort. LOOKOUT COUNTY raced close to the pace inside, bid along the rail on the turn, angled out past the eighth pole and earned show. GERI'S CAR raced mid pack, eased out in the upper stretch and finished well. YEA IM A REDHEAD was never far off the pace, went five wide leaving the turn and offered a mild bid only. GLORIOSO was outrun in an even effort. MISS LAKE stalked the pace to the second turn and flattened out. RUBYLONGSTOCKINGS was not a factor. KARMEKIZZ failed to contend. The rider of LOOKOUT COUNTY claimed foul against the rider of CLASSIC JOURNEY for alleged interference at the top of the stretch. No change was made.
